Camper Information & Rules

- “ Camper application must be completed in full with proper information and mailed in or hand delivered with the appropriate fee by the deadline of July 30th.
- “ New York State Department of Health Regulations are:
 - All campers must have a working fire extinguisher within.
 - No open awnings.
 - No open fires or barbeque grills.
 - No dumping of waste water or gray water on the ground.
- “ Awnings on campers, next to Animal barns ONLY, will be allowed.
- “ E-Z up tents (NO SIDES ALLOWED) and umbrella's by the barns, MUST be secured down.
- “ If you fill your fresh water tank , the hose must be disconnected from the faucet & camper & stored away.
- “ All persons staying on the grounds must have a wristband. No one under 18 years of age may occupy the camper/tent overnight unless a chaperone is present. Unlisted persons in camper/tent are in violation of the rules & may be evicted from the camper/tent.
- “ Camper/Tents in barns 1, 2, 3, 6, 7, & 9 will be placed on the grounds through a lottery drawing. Lottery results will be notified the Thursday evening prior to Fair. Camper/tents will be placed on the grounds at the discretion of the camper committee.
- “ Camper placement hours the weekend before Fair will be FRIDAY 1—8pm, SATURDAY 10am—6pm, and SUNDAY 10am—6pm. DO NOT PLACE CAMPER/TENT WITHOUT APPROVED SUPERVISION.
- “ All campers must be in place by SUNDAY at 6:00pm.
- “ All Campers/Tents must be pre—registered and paid for at the Fair Office BY July 30th @ 6 pm
- “ Camper permit must be displayed on the camper/tent. Attach permit on the latch side of doorway on the outside of camper. Permit must be visible at all times.
- “ Tank pump-outs will be available Tuesday— Saturday early mornings of Fair. Each pump-out will cost \$25.00. Registration for pump-outs must be made the day BEFORE the service by 6 pm. You will receive your ticket upon payment.
- “ All Campers/tents must use OUTDOOR Lead cords of #12—3 size or bigger. The use of frayed, taped or otherwise unsafe cords is prohibited.
- “ Air conditioners may be used in designated areas only. Air conditioners are NOT ALLOWED by campers placed by the barns. Any violations to this rule will not be allowed by the barn camping in the future.
- “ When exhibiting a Chicken or Rabbit only, camping will NOT be guaranteed. You will be placed on a waiting list.
- “ If located in NEW CAMPER AREA— 1 Vehicle is allowed per camper & cannot be parked in the fire lane.
- “ All violations and fines by NYS Dept. of Health will be the responsibility of the signer of the permit.
- “ Washington County Fair, Inc. is not liable or responsible for theft or damage to the camper/tent and /or its contents by fire, the elements or in any other manner what-so-ever.
